1. Tenders received after the stipulated **due date and time** shall not be considered. **C R RAO AIMSCS** shall not be responsible for any postal or courier delays.
2. Quotations shall remain valid for a period of **90 days** from the date of submission. No revision in rates will be permitted after submission. The quoted rates shall remain firm until execution of the purchase order.
3. Quotations must be submitted on the **firm's official letterhead**, clearly mentioning, Contact telephone numbers and Email address, GST/VAT/CST/Service Tax registration details, Performance Bank Guarantee details (if applicable), Delivery period, Warranty period, PAN/TIN registration details, and any other applicable charges. **Vendor should enclose valid Authorized dealer certificate. Failure to include these details will result in rejection.**
4. The purchase quantity may be **increased or decreased** at the time of order, depending on requirements and budget availability.
5. **Post-warranty service terms** must be clearly specified. Availability of a **local service center in Hyderabad** will be preferred.
6. Materials shall be delivered at the **Administrative Office, CR Rao AIMSCS**. No transportation or freight charges shall be paid separately.
7. All other terms and conditions shall be governed by the **CR Rao AIMSCS Purchase Policy**.

- In case of delay in supply or installation beyond the stipulated period, liquidated damages may be levied at a rate specified by CR Rao AIMSCS, subject to a maximum ceiling.

- The vendor shall provide free replacement/repair of defective parts during the warranty period.

20. Performance Security

- Successful bidder may be required to submit a Performance Bank Guarantee (PBG) equivalent to a specified percentage of the contract value, valid for the warranty period.

21. Taxes & Duties

- All applicable taxes, duties, and levies shall be clearly indicated in the quotation.
- Statutory variations, if any, shall be governed as per Government norms.

22. Force Majeure

- Neither party shall be held responsible for failure or delay due to events beyond reasonable control, such as natural calamities, war, strikes, or government restrictions.

23. Termination Clause

- CR Rao AIMSCS reserves the right to terminate the contract partially or fully in case of breach of terms, non-performance, or unsatisfactory service.

24. Confidentiality

- Vendors shall maintain confidentiality of all information related to CR Rao AIMSCS and shall not disclose any data to third parties without prior written consent.

25. Arbitration & Jurisdiction

- Any disputes arising out of the tender shall be subject to Hyderabad jurisdiction.
- Disputes shall be resolved through arbitration as per the Arbitration and Conciliation Act, 1996.

26. Blacklisting / Integrity Clause

- Vendors blacklisted by any Government/PSU/Autonomous body are not eligible to participate.
- Vendors must submit a self-declaration regarding non-blacklisting.

27. Subcontracting

- Subcontracting of the awarded work shall not be permitted without prior written approval of CR Rao AIMSCS.
