 - 3.** Quotations must be submitted on the **firm's official letterhead**, clearly mentioning, Contact telephone numbers and Email address, GST/VAT/CST/Service Tax registration details, Performance Bank Guarantee details (if applicable), Delivery period, Warranty period, PAN/TIN registration details, and any other applicable charges.
 - 4.** The purchase quantity may be **increased or decreased** at the time of order, depending on requirements and budget availability.
 - 5.** Delivery shall be completed within **2–3 weeks** from the date of issue of the purchase order.
 - 6.** Materials shall be delivered at the **Administrative Office, CR Rao AIMSCS**. No transportation or freight charges shall be paid separately.
 - 7.** Payment shall be released within **10 working days** after successful **supply and installation**. **No advance payment** shall be made.

- 8. A Bid Security (EMD) of ₹25,000/- (Rupees Twenty Five Thousand only)** shall be drawn in favour of **"C R RAO AIMSCS"**, payable at **Hyderabad**, and must be submitted **only with the Technical Bid**.

 - The vendor shall provide free replacement/repair of defective parts during the warranty period.
 - 12. Post-warranty service terms** must be clearly specified. Availability of a **local service center in Hyderabad** will be preferred.
 - 13.** All other terms and conditions shall be governed by the **CR Rao AIMSCS Purchase Policy**.
 - 14. CR Rao AIMSCS** reserves the right to accept or reject any or all tenders, wholly or partially, without assigning any reason. The decision of CR Rao AIMSCS shall be **final and binding**.
 - 15.** Vendors must possess **prior experience** in supply, installation, and system integration for **government or similar organizations**. Supporting documents may be enclosed.
 - 16. Bid Opening & Evaluation**
 - Technical bids will be opened first. Only vendors who qualify technically will be considered for opening of the commercial bid.
 - The decision of the Tender Committee regarding technical qualification and bid evaluation shall be final and binding.
 - 17. Bid Submission Mode**
 - Bids must be submitted in two-bid system (Technical Bid and Commercial Bid) in separate sealed envelopes, clearly superscribed.

- Late, conditional, or incomplete bids will be rejected summarily.

18. Clarifications & Amendments

- CR Rao AIMSCS reserves the right to seek clarification from bidders during evaluation.
- Amendments or corrigenda, if any, shall be notified on the official website/email and will form part of the tender document.

19. Liquidated Damages / Penalty

- In case of delay in supply or installation beyond the stipulated period, liquidated damages may be levied at a rate specified by CR Rao AIMSCS, subject to a maximum ceiling.

20. Taxes & Duties

- All applicable taxes, duties, and levies shall be clearly indicated in the quotation.
- Statutory variations, if any, shall be governed as per Government norms.

21. Force Majeure

- Neither party shall be held responsible for failure or delay due to events beyond reasonable control, such as natural calamities, war, strikes, or government restrictions.

22. Termination Clause

- CR Rao AIMSCS reserves the right to terminate the contract partially or fully in case of breach of terms, non-performance, or unsatisfactory service.

23. Confidentiality

- Vendors shall maintain confidentiality of all information related to CR Rao AIMSCS and shall not disclose any data to third parties without prior written consent.

24. Arbitration & Jurisdiction

- Any disputes arising out of the tender shall be subject to Hyderabad jurisdiction.
- Disputes shall be resolved through arbitration as per the Arbitration and Conciliation Act, 1996.

25. Blacklisting / Integrity Clause

- Vendors blacklisted by any Government/PSU/Autonomous body are not eligible to participate.
- Vendors must submit a self-declaration regarding non-blacklisting.

26. Subcontracting

- Subcontracting of the awarded work shall not be permitted without prior written approval of CR Rao AIMSCS.

27. Compliance with Laws

- The vendor shall comply with all applicable Central and State laws, rules, and regulations during execution of the contract.

28. Bid Security Forfeiture

- Bid Security/EMD shall be forfeited in case of withdrawal or modification of bid during validity period or failure to execute the contract after award.
